Rules of the Conference

Will only read the first six rules of the 31 (A copy of the 31 rules are on the Dept. Website).

Rule 1: Robert's Rules of Order, revised, will govern except as hereinafter specifically stated, and when not in conflict with the Disabled American Veterans Constitution and Bylaws and the Rules of the Convention.

Rule 2: For the purpose of recognition, a member of the Convention must (a) address the chair as Comrade Commander; (b) state name and chapter or title; (c) proceed only after recognition from the chair.

Rule 3: Debate on any question shall be limited to five minutes for each speaker except by consent of two-thirds of the delegates present.

Rule 4: Not more than two (2) representatives from any one Chapter shall be permitted to discuss any one subject except by a two-thirds (2/3) consent.

Rule 5: Recognition shall be granted only once to any one speaker on any one subject. A rebuttal of not more than two minutes may be permitted. Additional recognition may be granted by two-thirds (2/3) consent.

Rule 6: No person who has spoken for or against any motion, resolution or report on the Convention floor shall be permitted to make a motion to table. A motion to table is not debatable and shall require a majority affirmation vote. A tabled motion may be taken from the table for reconsideration by a majority vote.

Commander Bailey: I'm going to turn the podium over Adjutant Cox to obtain possible DEC approval for a land purchase.

Adjutant Cox: The department Board of Directors has been looking into the possibility of opening a new thrift store at some point. We had feelers out for property and found a 3.5-acre plot located at 4361 George Washington Memorial Highway, Yorktown. Our current thrift store management company, who has years of experience, and has done an excellent job managing the current thrift stores has done in-dept research on the property.

The property was listed for \$695,000. We made an offer of \$600,000, which was a low-ball offer. They came back with a counter offer of \$690,000.

We made a counter of \$650,000 (cash) which they accepted. The initial letter of intent, dated 1/14/22, per a review by our law firm, was altered to reflect the change. The due diligence period began with a completion date of 3/20/22. There are costs associated with meeting the requirements of the due diligence.

Mike long met with his attorney, who specializes is commercial real estate. He advised we would have to have an environmental study completed. The good point is, there is a grant available to do this study. The application has been completed and we don't anticipate any problems. We have made contact with the property owner to have the due diligence date moved to 4/15/2022 to allow for this study to be completed. I was notified yesterday the request to change the due diligence date to 4/15/22 was approved by the property owner.

I want to make this clear, this is just purchase of land as a potential site for a thrift store. If we would decide to go further with the building of a thrift store, it would have to come before and be approved by the DEC. Then the department would have to seek approval of the National Executive Committee.

The current assessed value of the land is \$801,600 so we are in the good to start out. The most recent sell of vacant commercial property zoned general business was on 8/20/21 at 2420 George Washington Memorial Hwy at the price of \$1,400,000.00 for 4 acres.

This not is a good time to build anything due to the price of building materials and the difficulty getting building materials.

A good example, I have told you that the Holiday Inn – Tanglewood was going to be completely renovated by the time of our 90<sup>th</sup> annual convention. Unfortunately, that will not happen. Everything has been approved, the contactor ready to go, but cannot start because of the delay in getting building materials. Their new start date is now October.

The Board of Director's approved the purchase and submitted the letter of intent which does not obligate the department until the due diligence date and with the approval of the DEC.

This was brought before the Finance Committee on Friday. David Cuff, chair was not able to attend the finance meeting due to family issues but ran the meeting via the phone.

A motion was made by <u>Mike Giles</u> second by <u>Tanya Culbert</u> to approve the purchase of the land.

The motion passed unanimously.

As a PDC and member of the DEC, I make a motion that the DEC approve the purchase of the above 3.5-acre plot located at 4361 George Washington Memorial Highway, Yorktown.

I brought before the finance committee, for consideration, a change to the current budget guidelines, section 2: General Guidelines, #3, 1<sup>st</sup> sentence which reads: official travel mileage shall be reimbursed at the rate of .42 cents per mile.

Due to the current gas prices, i recommended that official travel mileage be reimbursed at a rate of .50 cents per mile.

A motion was made by <u>Steve Perkins</u> second by <u>Tanya Culbert</u> to approve to change the mileage reimbursement rate to .50.

The motion passed unanimously.

Commander Bailey: Since the budget guidelines are approved by the DEC during the 4<sup>th</sup> DEC meeting it requires the approval of the DEC to make this change.
